A. PATTERN OF ASSESSMENT TEST

Question paper will be of 100 marks, containing 50 multiple choice questions carrying 2 marks each.

The GST Act, 2017 and Notifications/Circulars issued till 30th June, 2017 will be applicable

B. PASSING MARKS

Passing marks for the Assessment Test is 50. The Institute is not undertaking any assessment in the strict sense but evaluating the capabilities inculcated through the learning process. The candidate securing less than 50% marks in the assessment test will have to re-appear in the test. No negative marking.

C. ASSESSMENT CENTRES
