Persons who aspire to become a faculty of Indirect Taxes are expected should meet the following basic requirements:

- a) Minimum 3 years of post-qualification experience in the field of Indirect Taxes.
- b) Knowledge on Indirect Taxes including GST ACTs AND RULEs, 2017 as question other than your topic would also be asked by the evaluator (Member may also refer BGM on GST ACTs and Rules, 2017 prepared by the Indirect Taxes which would be available by 24<sup>th</sup> August, 2017 on the website of the committee <u>www.idtc.icai.org</u>.
- c) Public speaking experience in training / seminars / class-room sessions, understanding audience expectation and keen classroom strategist.

## Participants who wish to present in local language would also be considered for being faculty within the region of the language. We request you to indicate your preference in application form itself.

Given the above, program is not meant only to provide training to the participants but to identify the new faculties to increase the pool of faculties with the following approach:

- 1. Volunteers will be required to make a 10-15 minute PPT presentation on **topic** of GST ACTs and Rules, 2017 to be communicated separately to the registered participants before 3 days of the programme.
- 2. The criteria for evaluation will be shared with the registered participants.
- 3. The shortlisted candidates from this training would be called for Four days comprehensive paid training on GST details which would be communicated separately.

Members who were unable to get through in the previous attempt in July/August/September, 2016 & March 2017 could prepare well and present again if they feel they can do better.

A fees of Rs. 500/- (Rupees Five Hundred Only) would be charged for this evaluation Programme.
